

Entities of the national economy in the REGON register in the Capital City of Warsaw. As of end of 2018

22.02.2019



At the end of 2018, there were 433 823 entities of the national economy registered, i.e. by 0.2% less than a year before. In the total number of entities, natural persons conducting economic activity prevailed (55.8%). The majority of entities (19.6%) conducted activity in trade; repair of motor vehicles, however the largest increase as compared to 2017 was recorded in the communication and information section (by 7.1%). Throughout 2018, there were 105 liquidated units per every 100 newly registered entities.


The largest increase in the number of entities compared to 2017 took place in the information and communication section (by 7.1%)

General characteristics of entities of the national economy

In the Capital City of Warsaw, at the end of December 2018, there were 433 823 entities of the national economy registered in the REGON register. They accounted for 53.1% of all entities in the voivodship and 9.9% of all units registered in the country. In comparison with the previous year, the number of entities in the Capital City of Warsaw decreased by 0.2%, and compared to 2010 it was higher by 26.0%. The largest increase in relation to 2017 was recorded in the following districts: Wilanów (by 9.0%), Białołęka (by 5.3%), Wesoła (by 2.3%). The largest decrease was noted in the districts: Śródmieście (by 4.1%), Praga-Północ (by 2.8%), Praga-Południe (by 1.2%), Mokotów (by 1.0%).

Over 53% of the voivodship's entities were registered in the Capital City of Warsaw


Chart 1. Entities of the national economy in the REGON register in 2010-2018



Most entities of the national economy in the districts of the Capital City of Warsaw were located in: Śródmieście (69 336) – 16.0%, Mokotów (58 400) – 13.5%, Wola (41 003) – 9.5% and in Praga-Południe (37 083) – 8.5%. The smallest number of entities were located in the following districts: Rembertów (4 133) – 1.0%, Wesoła (5 157) – 1.2%, Ursus (9 600) – 2.2% and Praga-Północ (11 206) – 2.6%. The vast majority, that is 407 531, i.e. 93.9% of the total number were private sector entities. There were 4 387 entities of the national economy registered in the public sector.

Most of the units were registered in Śródmieście, while the least in Rembertów

Entities of the national economy by legal status


In the Capital City of Warsaw the dominant organizational form of registered entities were natural persons conducting economic activity. As of 31 December 2018, their number amounted to 242 003, i.e. by 4.5% more than in the previous year. The largest increase was recorded in the districts: Wilanów (by 12.0%), Białołęka i Żoliborz (both by 7.3%). No decrease in the number of natural persons was recorded in any district. The largest share of natural persons in the total number of entities was recorded in Bemowo (75.5%), while the smallest in Śródmieście district (24.1%).

The number of registered commercial companies amounted to 126 471 and accounted for almost 80% of all commercial companies registered in Mazowieckie voivodship. Over the year their number in the capital city decreased by 7.0%. The decrease, which was recorded in almost all districts, the highest level reached in Bielany (a decrease by 20.6%), Praga-Południe (by 17.0%), Praga-Północ (by 16.6%), Rembertów (by 15.1%). The increase (by 4.5%) was recorded in one district – Wilanów.

Commercial companies were dominated by capital companies (89.5%) and they were mainly limited liability companies (86.6%). In the group of partnerships (10.5%), prevailed limited partnerships (6.3% of total partnerships) and unlimited partnerships (2.7%).

Most of the natural persons conducting economic activity were based in the Mokotów district

At the end of December 2018, the number of registered civil law partnerships amounted to 32 880, i.e. by 0.4% more than a year before. The highest increase was recorded in the following districts: Białołęka (by 3.4%), Wilanów (by 1.3%) and Włochy and Żoliborz (both by 0.9%). A slight decrease was recorded in two districts: Wawer and Bielany.

The number of registered associations and social organizations amounted to 6 838, which means a decrease by 10.0% as compared to the previous year. The largest decrease was recorded in the following districts: Śródmieście (by 16.1%), Żoliborz (by 13.0%), Mokotów (by 12.2%), Włochy (by 11.0%). The increase concerned the districts: Wesoła (by 7.1%), Wilanów (by 3.8%), Ursus (by 2.2%).

There were 6 423 foundations in the Capital City of Warsaw, i.e. by 8.5% less than in December 2017. The largest decrease was recorded in Śródmieście (by 13.9%), Praga-Północ (by 11.7%), Mokotów (by 11.4%), Bielany (by 10.3%), whereas the increase concerned the following districts: Wilanów (by 8.0%), Rembertów (by 6.3%), Białołęka (by 5.5%) and Wesoła (by 4.1%).

At the end of 2018, there were 839 cooperatives in the register, i.e. by 45.9% less than a year before. The largest decrease was recorded in Rembertów (by 71.4%) and in Ursus and Wesoła (both by 66.7%). No growth was recorded in any district.

At the end of December 2018, there were 10 state owned enterprises registered in the REGON register, which was a decrease by 80.4% compared to the previous year.


Entities of the national economy by kind of conducted activity

At the end of December 2018, the most numerous group of entities were units conducting activity in the field of: trade; repair of motor vehicles (19.6%), professional, scientific and technical activity (19.1%), information and communication (9.3%), construction (7.2%). The section of trade; repair of motor vehicles was dominant in most districts of the Capital City of Warsaw, except for Wilanów, Żoliborz, Ursynów, Mokotów, where entities conducting professional, scientific and technical activities prevailed.

Compared to 2017, the number of entities of the national economy increased, among others, in the following sections: information and communication (by 7.1%), education (by 5.7%), human health and social work activities (by 4.7%).

The most numerous group of entities according to the kind of conducted activity were units dealing in trade; repair of motor vehicles

Entities of the national economy by number of employed persons

In the Capital City of Warsaw, the vast majority of entities constituted units from the micro enterprises group (i.e. entities with expected number of employees up to 9 persons), which accounted for 96.3% of total registered units. The share of small entities (with expected number of 10 to 49 employees) amounted to 2.9%, and medium-sized enterprises (expected number of 50 to 249 employees) and large (with 250 and more employed persons), respectively 0.6% and 0.2%.

Micro enterprises most often conducted activity in the following sections: trade; repair of motor vehicles, professional, scientific and technical activities; information and communication as well as construction.

In the group of small enterprises, in addition to trade; repair of motor vehicles, units conducting activity in the field of industry, construction and professional, scientific and professional activities were also dominant. Among the medium-sized enterprises, the sections of industry and trade; repair of motor vehicles prevailed. Large units conducted their activities primarily in the following sections: trade; repair of motor vehicles, industry and sections related to arts, entertainment and recreation.

Entities of the national economy newly registered and deregistered


In 2018, 37 348 new entities of the national economy were registered in the REGON register, i.e. by 5.0% more than a year before. Most new registrations were recorded in the section of professional, scientific and technical activities (8 903).

Compared to 2017, the number of entities removed from the register increased (by 87.3%) and amounted to 39 048 units. Most deregistration was recorded in the section of trade; repair of motor vehicles (12 053).

Over 96% of all entities were micro enterprises

There were 105 liquidated units per every newly registered entities in 2018

a The increase in the number of entities deregistered in 2011 and 2018 was affected by the update of the REGON register based on information about deceased persons obtained from the PESEL register and an update based on information from the National Court Register on entities deleted from the National Court Register.

Entities of the national economy per 1 000 population

In the capital city, there were 245 entities of the national economy registered in the REGON register per 1 000 population. This rate was the highest in the following districts: Śródmieście (597), Wilanów (306) and Włochy (298), and the lowest in: Ursus (161), Rembertów and Białołęka (both by 171).

Map 1. Entities of the national economy per 1 000 population in 2018


