

Entities of the national economy in the REGON register in Warszawa. As of the end of 2022.


At the end of 2022, there were 525475 entities of the national economy registered, i.e. by 5.3% more than a year before. In the total number of entities, natural persons conducting economic activity prevailed (54.7%). The majority of entities (19.4%) conducted professional, scientific and technical activities. Out of the total number of entities, the vast majority (91.7%) belonged to the private sector.

General characteristics of entities of the national economy

In m.st. Warszawa at the end of December 2022, there were 525475 entities of the national economy registered in the REGON register. They accounted for 54.2% of all entities in the Voivodship and 10.5% of all units registered in the country.

In comparison with the previous year, the number of entities in Warsaw increased by 5.3%, and compared to 2015 it was higher by 30.9%. The largest increase in relation to 2021 was recorded in the following districts: Wola (by 8.8%), Wilanów (by 7.7%), Włochy (by 7.2%), Praga-Północ (o 6.6%). The decrease was not recorded in any district.

Out of the districts of m.st. Warszawa, most entities of the national economy were located in: Śródmieście 15.9%, Mokotów 13.4%, Wola 10.1%. The smallest number of units was based in the following districts: Rembertów 0.9%, Wesoła 1.1%.

The vast majority 91.7% of the total number were private sector entities, whereas 4756 entities of the national economy were registered in the public sector.

Over 54% of the Voivodship's entities were registered in m.st. Warszawa

Most of the units were registered in Śródmieście, while the least in Rember-

In m.st. Warszawa, the dominant organisational form of registered entities were natural persons conducting economic activity. As of 31 December 2022, their number amounted to 287545, i.e. by 5.2% more than in the previous year. The largest increase was recorded in the districts: Wola (by 9.3%), Wilanów (by 8.0%), Włochy (by 7.6%). No decrease in the number of natural persons was recorded in any district. The largest share of natural persons in the total number of entities was recorded in Bemowo (75.3%), while the smallest in Śródmieście district (22.9%).


The number of registered commercial companies amounted to 167965 and accounted for almost 80.0% of all commercial companies registered in Mazowieckie Voivodship. Over the year their number in the capital city increased by 6.9%. An increase was recorded in all districts, and the highest level was reached in Praga-Północ (by 13.3%), Rembertów (by 11.4%), Wola (by 10.2%), Włochy (by 8.7%).

Commercial companies were dominated by capital companies (91.7%) and they were mainly limited liability companies (89.3%). In the group of partnerships (8.3%), prevailed limited partnerships (5.0% of total partnerships) and unlimited partnerships (2.2%).

The largest increase in the number of natural persons in relation to the previous year was recorded in the Wola district

At the end of December 2022, the number of registered civil law partnerships amounted to 33325, i.e. by 14 more than a year before. The highest increase was recorded in the following districts: Praga-Południe (by 5.4%), Rembertów (by 1.1%), Bielany (by 0.9%), Wilanów (by 0.6%). The largest decrease was recorded in the districts: Białołęka (a 6.8% decrease), Mokotów and Żoliborz (a 1.2% decrease).

The number of registered associations and social organisations amounted to 7869, which means an increase by 4.3% as compared to the previous year. The largest increase was recorded in the following districts: Targówek (by 42.7%), Ursus (by 7.3%), Bielany (by 6.0%). There was no decrease in any district.

There were 8050 foundations in m.st. Warszawa, i.e. by 7.7% more than in December 2021. The largest increase was recorded in the following districts: Włochy (by 19.0%), Białołęka (by 13.2%), Praga-Południe (by 10.0%). There was no decrease in any district.

At the end of 2022, there were 839 cooperatives in the REGON register, i.e. the same number as in the previous year.

The number of state owned enterprises decreased by 1 compared to the previous year and at the end of December 2022 amounted to 7 enterprises.

Entities of the national economy by kind of conducted activity


At the end of December 2022, the most numerous group of entities were units conducting activity in the field of: professional, scientific and technical activities (19.4%), trade; repair of motor vehicles (17.5%), information and communication (11.8%). The section of trade; repair of motor vehicles was dominant in the following districts: Bielany, Ochota, Praga-Północ, Rembertów, Targówek, Ursus, Wawer, Wesoła and Włochy. Whereas entities conducting professional, scientific and technical activities prevailed in the districts: Bemowo, Białołęka, Mokotów, Praga-Południe, Śródmieście, Ursynów, Wilanów, Wola and Żoliborz.

Compared to 2021, the number of entities of the national economy increased, among others, in the following sections: activities of households as employers and products-producing activities of households for own use (by 25.0%), information and communication (by 16.8%), administrative and support service activities (by 7.0%), health care and social welfare (by 6.2%).

The most numerous group of entities according to the kind of conducted activity were units dealing with professional, scientific and technical activities

In m.st. Warszawa, the vast majority of entities constituted units from the micro enterprises group (i.e. entities with expected number of employees up to 9 persons), which accounted for 97.0% of total registered units. The share of small entities (with expected number of 10 to 49 employees) amounted to 2.3%, and medium-sized enterprises (expected number of 50 to 249 employees) and large (with 250 and more employed persons), respectively 0.5% and 0.1%.

Micro enterprises most often conducted activity in the following sections: professional, scientific and technical activities, trade; repair of motor vehicles, information and communication as well as construction. In the group of small enterprises, in addition to trade; repair of motor vehicles, units conducting activity in the field of industry, construction and professional, scientific and professional activities were also dominant. Among the medium-sized enterprises, the sections of industry and trade; repair of motor vehicles prevailed. Large units conducted their activities primarily in the following sections: industry, trade; repair of motor vehicles, public administration and defence: compulsory social security as well as professional, scientific and technical activities.

Entities of the national economy newly registered and deregistered

In 2022, 45339 new entities of the national economy were registered in the REGON register, i.e. by 17.5% more than a year before. Among them, 28370 are natural persons conducting economic activity. Most new registrations were in the sections: information and communication (10156), professional, scientific and technical activities (8869), trade; repair of motor


In comparison with 2021, the number of entities removed from the register increased (by 27.7%) and amounted to 18035 units, of which 12981 are natural persons conducting economic activity. The most removals from the register were recorded in the following sections: trade; repair of motor vehicles (3678), professional, scientific and technical activities (3374), information and communication (1654), construction (1373), and transportation and storage (1299).

There 40 liquidated units per every 100 newly registered entities in 2022

Entities of the national economy with suspended activity

At the end of December 2022, the number of entities with suspended activity per year was higher by 17.4% and amounted to 57210. Among these entities, the vast majority (85.0%) were natural persons conducting economic activity.

Chart 5. Entities of the national economy newly registered and removed from the register





Entities of the national economy per 1 000 population¹

In the capital city, there were 282 entities of the national economy registered in the REGON register per 1 000 population. This rate was the highest in the following districts: Śródmieście (824), and the lowest in: Ursus and Białołęka (by 174 each), Targówek (187), Rembertów (190).
