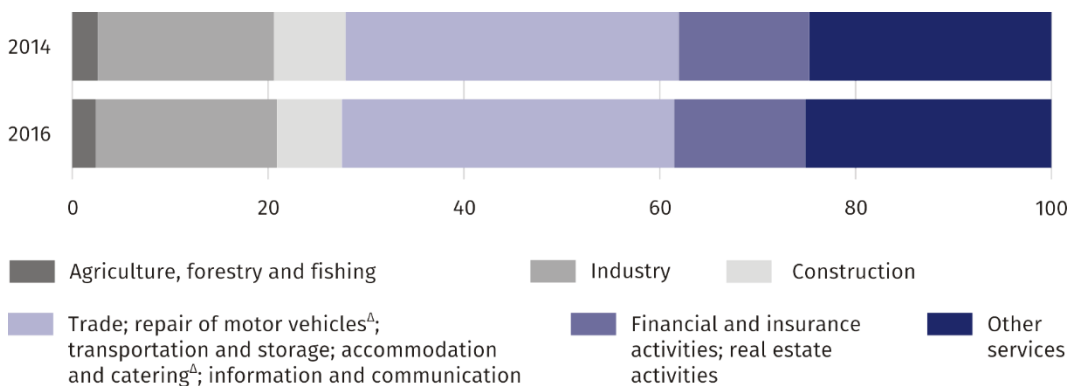
In 2016, the gross value added in Mazowieckie voivodship amounted to PLN 366 062 million, of which 72.4% was generated by service enterprises. Compared to the previous year, the share of service sector increased by 0.7 pp.

Gross value added (GVA) measures the newly generated value as a result of the production activities of domestic institutional units. GVA generated in Mazowieckie voivodship in 2016 amounted to PLN 366 062 million and as compared to the previous year it was higher by 3.4%. The share of this voivodship in generating GVA amounted to 22.3% and was by 0.1 pp higher both in relation to 2015 and to 2014. Labour productivity, measured by the gross value added per 1 employed person, amounted to PLN 147 962 and was higher than the national average by 29.9%.

GVA in 2016 was by 3.4% higher than a year before

In 2014–2016 in Mazowieckie voivodship, as in the country, the largest share in generating the gross value added achieved units conducting economic activity in the field of trade; repair of motor vehicles; transportation and storage; accommodation and catering; information and communication, and the smallest share – units conducting activity in agriculture, forestry and fishing.

Chart 1. Structure of gross value added by kind of activity (in %; current prices)



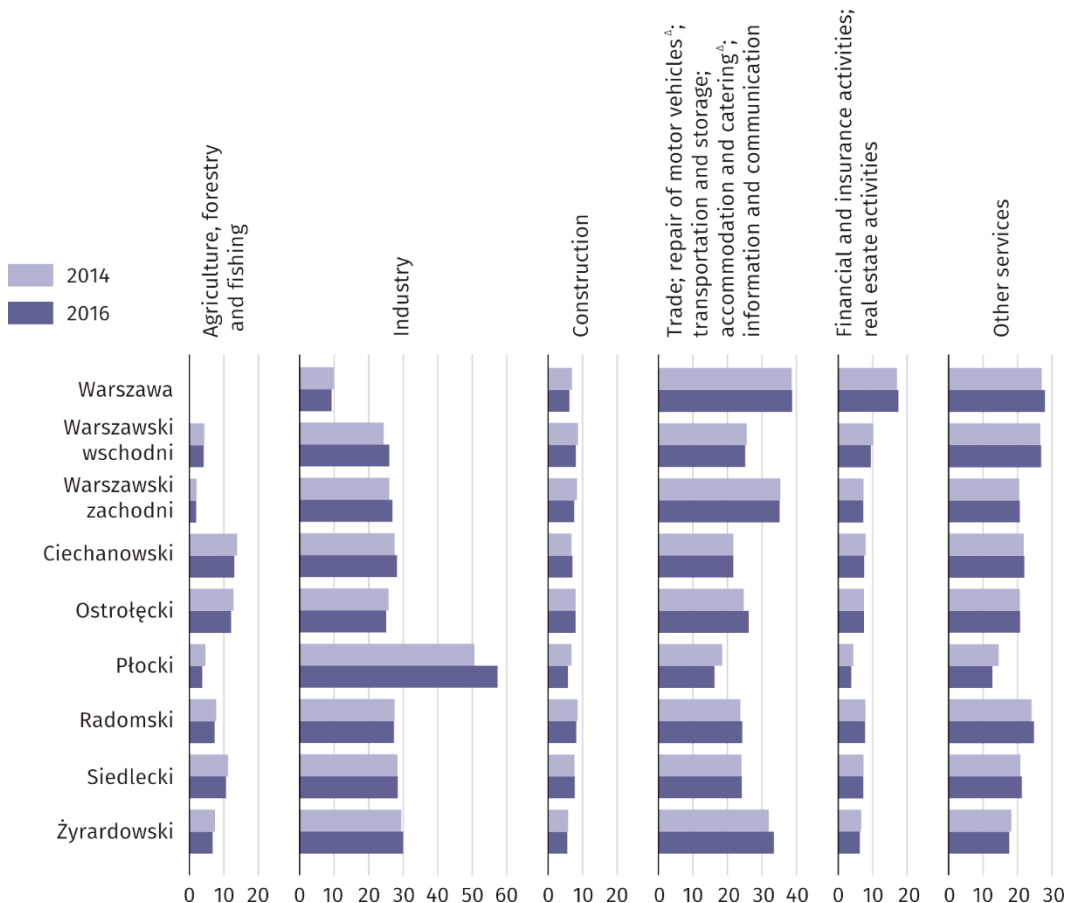
The share of industrial units in generating GVA increased

In 2016, units conducting activity in the field of trade; repair of motor vehicles; transportation and storage; accommodation and catering; information and communication generated 33.9% of the voivodship's GVA, i.e. by 0.1 pp less than in 2014. The share of units providing other services (of which public administration and defence; compulsory social security) accounted for 25.1% of GVA in the voivodship and compared to 2014 it increased by 0.4 pp. Industrial units generated 18.5% of the voivodship's gross value added, i.e. by 0.5 pp more than two years earlier. Units conducting financial and insurance activities; real estate activities generated in 2016 13.4% of the voivodship gross value added, i.e. by 0.1 pp more than in 2014. Industrial units generated 6.6% of GVA in the voivodship, i.e. by 0.7 pp less than two years earlier. The share of agriculture, forestry and fishing in generation of the voivodship's gross value added in 2016 amounted to 2.4% and was by 0.2 pp smaller than in 2014.

The described generic structure of the economy varied in individual subregions forming the macroregion of Mazowieckie voivodship¹. In 2016, significant differences in the share of industrial units in generating gross value added were reported, ranging from 9.5% in Warszawa to 57.6% in płocki subregion (in 2014, from 10.1% to 50.9% respectively). The share of entities conducting activity in the field of trade; repair of motor vehicles; transportation and storage; accommodation and catering; information and communication in generating gross value added ranged from 16.3% in płocki subregion to 38.8 in Warszawa (in 2014, from 18.5% to 38.7%; in the same subregions). The share of construction units varied the least – in 2016, 5.6% in żyrardowski subregion to 8.2% in radomski (in 2014, 5.9% in żyrardowski to 8.7% in warszawski wschodni).

The largest share of industry was reported in płocki subregion



In 2014–2016, the largest changes in the generic structure of the economy of individual subregions were observed in the industry (from minus 0.7 pp in ostrołęcki to plus 6.7 pp in płocki). Slightly smaller changes occurred in trade; repair of motor vehicles; transportation and storage; accommodation and catering; information and communication (from minus 2.2 pp in płocki to plus 1.5 pp in żyrardowski). Changes reported in other kinds of activities ranged from minus 1.9 to 0.9 pp. It is worth mentioning that in all subregions (except for Warszawa) the share of units conducted activity in the field of agriculture, forestry and fishing decreased. In turn, only Warszawa reported an increased share of units conducting financial and insurance activity; real estate activities.
