

Foreigners on the Mazovian labour market during the COVID-19 pandemic in 2020




2020 was the first year since 2013, when the number of work permits for foreigners decreased annually and amounted to 68.2 thousand. In 2020, they were issued by 21.0% less than in 2019. Work permits were most often issued to Ukrainian citizens.

In 2020, the Mazovian voivode issued 68.2 thousand work permits for foreigners, i.e. by 21.0% less than in the previous year. Most work permits for foreigners were issued in Mazowieckie Voivodship (followed by Wielkopolskie - 50.3 thousand, Łódzkie - 41.4 thousand and Małopolskie - 39.4 thousand). The predominance of Mazowieckie Voivodship is clear, however, the share of this voivodship in the total number of permits issued has decreased from 37.8% to 16.8% since 2016 (from 37.8% to 19.4%).

Most (17%) work permits for foreigners were issued in Mazowieckie Voivodship

The number of work permits issued for foreigners in 2020 was almost three times higher than in 2011.


In Mazowieckie Voivodship, the vast majority (97.6%) were work permits issued for the first time. In 2020, 1611 extensions of permits were issued, i.e. 2.4% of their total number. The number of consents for continuing work of foreigners was higher than in 2019 by 23.8%.

The majority – 44.7%, i.e. 65.6% of work permits for foreigners were issued to Ukrainian citizens. Compared to 2019, their share increased by 3.3 pp.

The vast majority of issued work permits concerned men. Their share in the total number of all permits issued in Mazowieckie Voivodship in 2020 amounted to 72.3%, but it was smaller than in 2019 (73.3%). The predominance of men in terms of permits occurred in all voivodships. The national average was 73.2% (from 64.8% in Łódzkie Voivodship to 85.6% in Podkarpackie). The number of permits issued, compared to 2019, was lower among women by 17.9% and among men by 22.1%.

Almost three out of four work permits were issued to men



Work permits for foreigners are issued for longer and longer periods of time. In 2020, the majority (52.0%) of work permits for foreigners were issued for a period of validity from 3 months to 1 year (compared to 57.9% in 2019). Whereas, permits with the longest validity period, i.e. for over 2 years, increased significantly and accounted for 44.2% of the total (compared to 37.4% in 2019). Short-term work permits with a validity period for up to 3 months accounted for only 0.1% of the total (0.3% in 2019).


Chart 3. Structure of work permits for foreigners by period of their validity in 2020



In 2020, the most permits were issued to employers from the construction section (18.4 thousand), which accounted for 27.0% of total permits (compared to 29.8% in 2019). Relatively large percentage represented foreigners working in transportation and storage (19.0%) and manufacturing (16.6%).

According to the occupations and specializations classification, foreigners who obtained a work permit in Mazowieckie Voivodshp in 2020, most often worked as industrial workers and craftsmen – 36.8% (compared to 40.2% in 2019), workers performing elementary occupations – 23.4% (compared to 22.7% in 2019), as well as plant and machine operators and assemblers – 18.6% (compared to 15.6%).

Most (37%) of foreigners worked as industrial workers and craftsmen
