

# Out-patient health care in Mazowieckie Voivodship in 2023

Increase in the number of outpatient consultations compared to 2022

At the end of 2023, out-patient health care was carried out by 3570 out-patient departments and 205 medical and dental practices providing services funded by public sources. In 2023, 56.4 million out-patient consultations were provided — 50.4 million medical and 5.9 million dental consultations.

## **Out-patient departments and medical practices**

At the end of 2023, there were 3775 providers of out-patient health care, of which 3570 outpatient departments<sup>1</sup> as well as 27 medical practices and 178 dental practices providing services funded by public sources.

Compared to 2022, the number of out-patient health care providers increased by 4.6%, with an increase only in urban areas, while a decrease was recorded in rural areas. The number of medical and dental practices i.e. those that signed contracts with the National Health Fund or with out-patient health care providers decreased (by 6.9% and 9.6%, respectively), mainly in urban areas.

At the end of 2023, 16% of out-patient departments were funded by public sources

At the end of 2023, there were 1460 persons per out-patient health care provider (by 55 persons fewer than a year before). The indicator in question was two times higher in rural areas (2752) than in urban areas (1161).

In Mazowieckie Voivodship, 93.5% of out-patient health care providers were adapted to the needs of the disabled. Most of the providers — 65.4% were equipped with ramps or platforms facilitating the entrance to the building, 36.4% had non-slip floors and 31.1% an elevator. 5.3% of out-patient health care providers had facilities for the visually impaired and the blind, and 5.1% for the hearing impaired and deaf.

### **Out-patient consultations**

In 2023, there were 56,380.0 thousand out-patient consultations provided, i.e. by 5.8% more than in 2022. The vast majority of consultations (87.4%) were provided in urban areas.


On average, there were more than 3.5 times out-patient consultations per urban than per rural inhabitant


Every ninth out-patient consultation was via telephone

The average number of out-patient consultations per capita in 2023 was 10.2, with the indicator over 3.5 times higher in urban than in rural areas and amounted to 13.8 and 3.7, respectively.

Consultations via telephone, i.e. consultations provided remotely using a telephone connection or another ICT system, accounted for 11.6% of all out-patient consultations provided (in 2022 — 14.5%).

21% of consultations via telephone within nighttime and holiday medical services were provided to children and youth under 18

Most out-patient consultations were provided in specialised care – 32,630.6 thousand, i.e. 57.9% of the total, including 10.5% by dentists. Consultations via telephone accounted for 12.2% of all specialised consultations provided.

Consultations provided in primary health care accounted for 40.8% of all out-patient consultations, and every ninth of them was provided via telephone. Primary health care doctors also provided 221.3 thousand, i.e. 1.0%, of consultations at the patient's home.

720.5 thousand consultations were provided within nighttime and holiday medical service, i.e. 1.3% of all out-patient consultations. Most of them were provided on an out-patient basis — 93.6%, while telephone consultations constituted 3.5%, and consultations at the patient's home — 2.9%.

Out-patient consultations were more often provided to women. In the field of specialist care they constituted 60.8%, in primary care — 57.9%, while within nighttime and holiday medical service — 55.9%.

In 2023, more than half - 52.8% of consultations were provided to persons aged 18-64, aged 65 years and more - 27.8%, and aged 0-17 years - 19.4%.


Children and youth in the age group 0-17 years were provided with 10,913.6 thousand consultations, of which 46.5% in primary health care (a decrease of 1.4 pp per year), 35.8% were specialised medical consultations (an increase of 1.1 pp), and 15.7% — dental consultations (an increase by 0.3 pp), and 2.0% — consultations within nighttime and holiday medical service (a 0.1 pp increase compared to 2022).

In the age group of 65 and more, there were 15,676.2 thousand consultations provided, the most in primary health care — 50.4% (a decrease by 0.5 pp per year). Consultations of specialised medical care accounted for 42.7% (a 0.2 pp increase), dental consultations —

Almost 60% of total outpatient health care consultations were provided to women 5.9% (a 0.2 pp increase), nighttime and holiday medical service consultations — 1.0% (a 0.1 pp increase).


Chart 2. Structure of out-patient consultations by type of consultation and age of patients in 2023

Most (3.9 million) medical consultations in specialised care were provided in surgical out-patient clinics

Compared to 2022, the number of specialised consultations in mental health clinics increased by nearly 11%
