


Entities of the national economy in the REGON register in Mazowieckie voivodship. As of the end of 2017

20.02.2018



At the end of 2017, there were 809369 entities of the national economy registered, i.e. by 2.7% more than in the previous year. Over half of the units (53.7%) were based in the Capital City of Warszawa. The largest number of entities (24.0%) dealt with trade; repair of motor vehicles, however the highest growth compared to 2016 occurred in the section information and communication (by 9.0%). During the whole 2017, there were 69 liquidated units per every 100 newly registered entities.


2017 was another year in which an increase in the number of entities of the national economy registered in the REGON register was recorded

General characteristics of entities of the national economy

In Mazowieckie voivodship at the end of 2017, in the REGON register 809369 entities of the national economy were registered, i.e. 18.8% of total entities registered in the country. In comparison to the previous year, the number of entities in Mazowieckie voivodship increased by 2.7%, and compared to 2010 it was higher by 18.8%.

Every fifth entity of the national economy, in the national REGON register was registered in Mazowieckie voivodship


Figure 1. Entities of the national economy registered in the REGON register in the years 2010–2017



Among the entities of the national economy registered in Mazowieckie voivodship, more than half had their seat in the subregion of Warszawa (434676), and 22.1% of units were located in subregions bordering with it (Warszawski zachodni – 101668 and Warszawski wschodni – 77032). The smallest number of entities was noted in the subregions Ciechanowski (25763) and Żyrardowski (26207) – the share of each of these units accounted for 3.2% of the voivodship total.

As many as ¾ of units registered in the voivodship had their seat in the Warszawa capital region


Figure 2. Structure of entities of the national economy by regions and subregions in 2017



Among powiats and cities with powiat status (except for the Capital City of Warszawa) most entities were registered in the powiats: Piaseczyński (33370) – 4.1%, Wołomiński (30127) – 3.7%, Pruszkowski (28260) – 3.5%, and also in Radom (24450) – 3.0%. While the smallest number of registered entities was in the powiats: Zwoleński (2236), Łosicki (2285), Lipski (2570), Żuromiński (2719), Białobrzeski (2757) and Przysuski (2801) – 0.3% each.

The largest number of entities were recorded in the powiats Piaseczyński (by 5.0%) and Zwoleński (by 4.7%) and in the Capital City of Warszawa (by 3.7%). Whereas the highest decrease was noted in the powiats: Makowski and Łosicki (both by 0.8%) and Ciechanowski (by 0.7%).

Map 1. Entities of the national economy per 1 km² by powiats in 2017




The number of registered units per 1 km² was 15 times higher in Warszawa capital region than in Mazowiecki regional

Entities of the national economy by kind of conducted activity

In Mazowieckie voivodship at the end of December 2017, the most numerous group of entities were units dealing with: trade; repair of motor vehicles – 194110, professional, scientific and technical activities – 116113, construction – 76716 and industry – 66111.

In comparison with 2016, the number of entities increased, among others, in the sections: information and communication (by 9.0%), administrative and support service activities (by 5.4%), professional, scientific and technical activities (by 5.2%). The decrease was recorded, among others, in the sections agriculture, forestry and fishing (by 1.9%) and education (by 0.7%).

Figure 3. Share of entities of the national economy by selected sections of PKD in 2017




Entities of the national economy by legal status

As in 2016, the vast majority, that is 774978, i.e. 95.8% of the total number of entities, was included in the private sector. Among entities of this sector, 66.3% constituted natural persons conducting economic activity primarily in: trade; repair of motor vehicles (120348 entities), professional, scientific and technical activities (80731 entities) and in construction (55319 entities).

There were 12327 entities of public sector registered in the REGON register, which belonged mainly to the education sector (5000 entities) and real estate activities (2592 entities).

Entities of the public sector constituted only 4.2% of total units in the voivodship At the end of December 2017, there were 514006 natural persons conducting economic activity registered in the REGON register, i.e. by 1.5% more than in the previous year. In the territorial cross-section, the largest increase was noted in the powiats Zwoleński (by 5.6%), Piaseczyński and Ostrołęcki – (both by 3.5%). The decrease concerned 11 powiats and Radom, Płock and Ostrołęka, of which the largest was noted in the powiats Ciechanowski (by 1.4%), Makowski and Radom (both by 1.0%).

The highest share of natural persons in the total number of entities was in the powiats: Ostrołęcki (83.2%) and Radomski (82.5%), while the lowest in the Capital City of Warszawa (53.3%) and in Piaseczyński powiat (64.4%).

The number of registered commercial companies amounted to 171229 and represented 31.9% of all commercial companies registered in the country. Over the year, their number in the voivodship increased by 8.0%, and the largest increase was recorded in the powiats: Nowodworski (by 13.6%), Żyrardowski (by 13.1%), Mławski (by 12.5%), Ostrołęcki (by 11.7%), Piaseczyński (by 11.3%). Decreases were noted in the powiats: Lipski (by 1.8%) and Przysuski (by 1.3%).

The vast majority of commercial companies represented companies (89.6%) and they were mainly limited liability companies (87.0%). Among partnerships (10.4%), the most popular legal forms were limited partnerships (5.1% of total commercial companies) and unlimited partnerships (4.1%)




Figure 5. Commercial companies by type of capital

The activity of commercial companies concentrated mainly in the following sections: trade; repair of motor vehicles (28.5%), professional, scientific and technical activities (16.3%), industry (10.1%), construction (9.4%) and information and communication (8.9%).

At the end of December 2017, the number of registered civil law partnerships amounted to 57800, i.e. by 0.4% more than in the previous year. Their largest increase was noted in the powiats: Ostrołęcki (by 4.3%), Pułtuski (by 4.2%), Żuromiński (by 3.7%). While the largest decrease was noted in the powiats: Łosicki (by 5.3%) and Kozienicki (by 2.1%) and in Radom (by 1.6%). Civil law partnerships concentrated their activity mainly in the sections: trade; repair of motor vehicles (41.4%), industry (12.1%) and professional, scientific and technical activities (10.5%).

As of the end of 31 December 2017, there were 17105 associations and social organizations registered, which means an increase by 4.2% compared to the previous year. The largest number of units increased in the powiats: Nowodworski (an 9.5% increase), Pruszkowski (by 9.2%) and Legionowski (by 7.7%). There was no decrease in any powiat or a city with powiat status.

The increase was also noted in the number of registered foundations (6.6% over a year) and at the end of December amounted to 8632. The number of foundations increased in 25 powiats and in all cities with powiat status, but decreased in two powiats – Sierpecki and Żyrardowski.

In Mazowieckie voivodship there were 3131 cooperatives registered, the same as in the previous year. The increase concerned 8 powiats and two cities with powiat status. The decrease was noted in 8 powiats and one city with powiat status, i.e. the Capital City of Warszawa. The above

legal status was usually chosen by units dealing with real estate activities – they accounted for 43.5% of all cooperatives.

At the end of December 2017, there were 59 state owned enterprises registered in the REGON register, the number of which remained the same compared to the previous year. Among these enterprises, most units dealt with professional, scientific and technical activities (27.1%) and industry (25.4%).

Entities of the national economy by the number of employed persons

In Mazowieckie voivodship, entities belonging to the micro-enterprises group predominated (the ones which at the moment of entering to the REGON register provided for employment of up to 9 persons), they accounted for 96.0% of all registered units. The share of small entities (with and estimated number of 10-49 employed persons) amounted to 3.2%, and medium-size (estimated number of employees 50-249 persons) and large enterprises (estimated number of employees 250 persons and more) amounted to 0.6% and 0.1% respectively.

Micro-enterprises most often conducted activities in the following sections: trade; repair of motor vehicles, professional, scientific and technical activities as well as construction. In the group of small enterprises, except for trade; repair of motor vehicles, dominated units dealing with industry and education. Among medium-size enterprises dominated sections: education, industry as well as trade; repair of motor vehicles. In the case of large enterprises, the highest share was in the sections: industry, trade; repair of motor vehicles as well as public administration and national defense; compulsory social security.



Newly registered and deregistered entities of the national economy

In 2017, there were 67057 newly registered entities of the national economy in the REGON register, i.e. by 1.2% less than in the previous year. Natural persons conducting economic activity accounted for 71.6% of total new entities, while the share of companies amounted to 24.4%. The largest number of units were established in the Capital City of Warszawa (35567) and in the powiats: Piaseczyński (3167), Wołomiński (2707) and Pruszkowski (2126). Whereas the smallest number of units were created in the powiats: Lipski (175), Łosicki (180), Białobrzeski (191) and Żuromiński (220).

During the year, 46585 entities were deregistered from the REGON register (by 0.6% less than during 2016) and they were mainly natural persons conducting economic activity (88.0%). The largest number of units were liquidated in the Capital City of Warszawa (20851), Wołomiński powiat (2029), Radom (1915) and Piaseczyński powiat (1903). In turn, the smallest number of liguidated entities was noted in the powiats: Zwoleński (142), Lipski (164), Łosicki (172), Białobrzeski (188).

a The increase of the number of liquidated entities in 2011 was affected by the update of the REGON register based on information on deceased persons obtained from the PESEL register and the update based on information from the National Court Register on entities liquidated from the National Court Register.

In 2017, there were 69 liquidate entities per every 100 newly registered entities, whereas this ratio was lower in the Warszawa capital region than in Mazowiecki regional it accounted for 64 and 87, respectively


The number of entities with suspended activity at the end of December 2017 amounted to 55557, i.e. by 1.7% more than in the previous year. The vast majority of these entities (90.3%) represented natural persons conducting economic activity.

In 2017, the indicator measured by the ratio of the number of units liquidated from the register to the number of newly registered units in the voivodship, amounted to 69.5%. The largest value of this rate was in Makowski powiat (100.7%), Radom (99.6%) and Białobrzeski powiat (98.4%). The lowest value was noted in the Capital City of Warszawa (58.6%) and in Zwoleński (59.2%) and Piaseczyński (60.1%) powiats.

Entities of the national economy per 1000 population

In 2017, in Mazowieckie voivodship, there were 150.6 entities of the national economy registered in the REGON register per 1000 population. The highest values of this rate were in the Capital City of Warszawa (247.2) and in the powiats: Piaseczyński (184.7), Pruszkowski (174.3), Warszawski Zachodni (167.2). Whereas the lowest intensity rate was in the powiats: Zwoleński (61.0), Ostrołęcki (62.2), Sierpecki (64.9) and Przysuski (66.2).
