

# Entities of the national economy in the REGON register in Mazowieckie Voivodship. As of the end of 2021.

Dynamics of entities of the national economy y/y

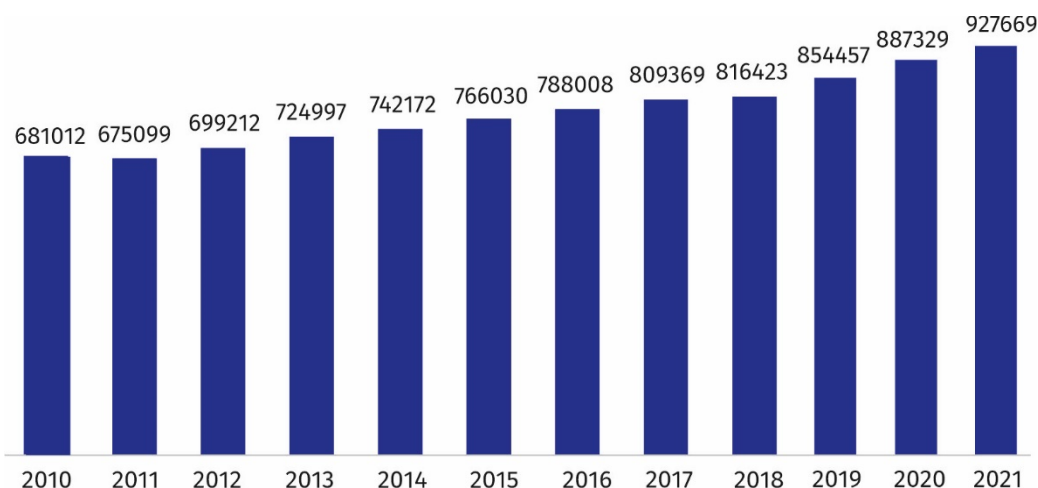
At the end of 2021, there were 927669 entities of the national economy registered, i.e. by 4.5% more than in the previous year. Over half of the units (53.8%) had their seat in m.st. Warszawa. The largest number of entities (20.8%) dealt with trade; repair of motor vehicles, however the highest increase as compared to 2020 occurred in the section of information and communication (by 11.8%).

## General characteristics of entities of the national economy

In Mazowieckie Voivodship at the end of December 2021, there were 927669 entities registered in the REGON register, i.e. 19.2% of the total entities registered in the country. Compared to the previous year, the number of entities in Mazowieckie Voivodship increased by 4.5%, and compared to 2010 it was higher by 36.2%.

Every fifth entity of the national economy in the REGON register was registered in Mazowieckie Voivodship

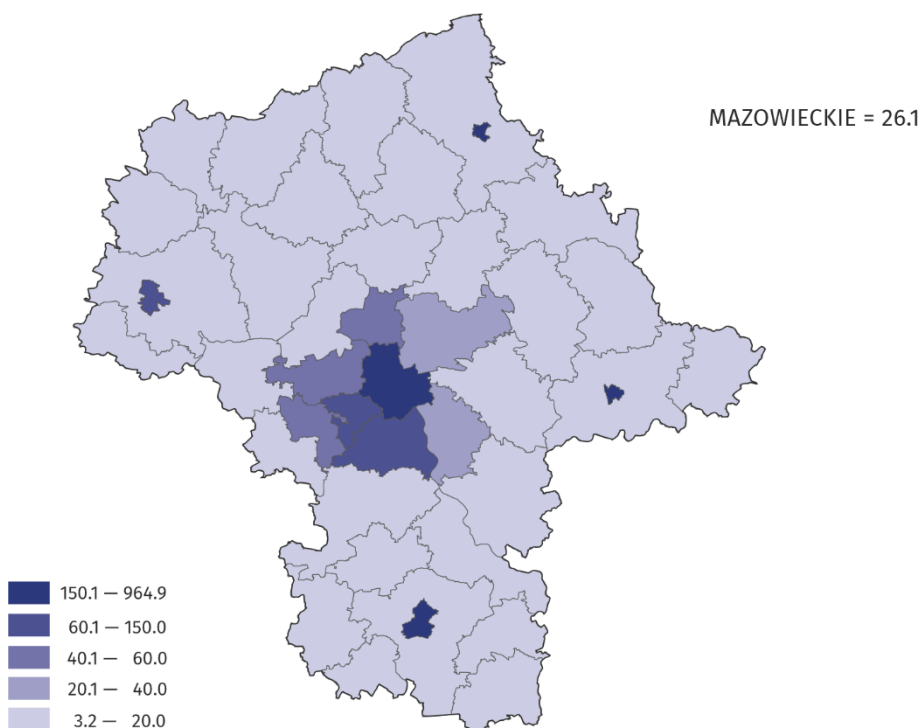
Chart 1. Entities of the national economy in the REGON register



Among powiats and cities with powiat status, the largest number of newly registered entities (except for m.st. Warszawa) were in the powiats: piaseczyński (39747) – 4.3%, wołomiński (36442) – 3.9%, pruszkowski (32399) – 3.5%, and in Radom (25720) – 2.8%. While the smallest number of registered entities was in the powiats: łosicki (2479), zwoleński (2589), lipski (2874), żuromiński (2903), białobrzegi (3096), przysuski (3136).

The largest increase in the number of entities was in ostrołęcki (by 5.8%), warszawski zachodni (by 5.6%), zwoleński (by 5.5%), legionowski (by 5.4%), grodziski and piaseczyński – by 5.3% each. The decline was not recorded in any powiat or city with powiat status.

**Map 1. Entities of the national economy per 1 km<sup>2</sup> by powiats in 2021**



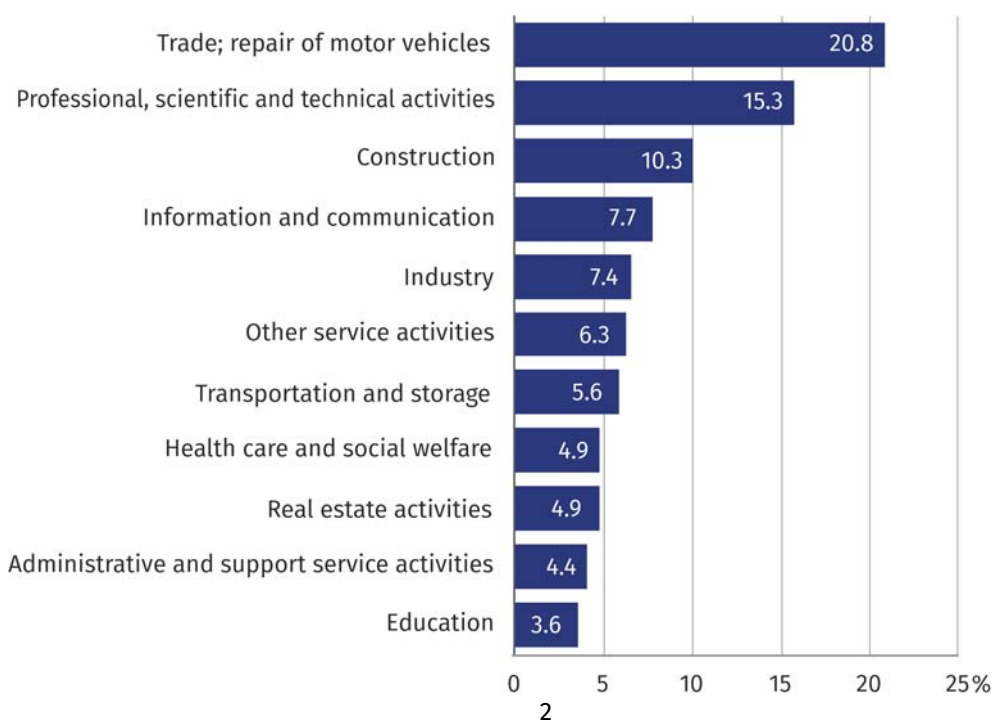
The number of registered units per 1 km<sup>2</sup> was 16 times higher in warszawski stoleczny region than in mazowiecki regionalny

**Entities of the national economy by kind of conducted activity**

In Mazowieckie Voivodship at the end of December 2021, the most numerous group of entities represented units conducting activity in the field of: trade; repair of motor vehicles – 192834, professional, scientific and technical activity – 141516, construction – 95664 and information and communication – 71872. Compared to 2020, the number of entities increased, among others, in the sections: information and communication (by 11.8%), health care and social welfare (by 6.6%), construction (by 6.3%), administrative and support service activities (by 6.2%), accommodation and catering (by 6.0%). A decrease was recorded only in the section of households employing workers and producing products for their own needs (by 10.0%).

### Entities of the national economy by legal status

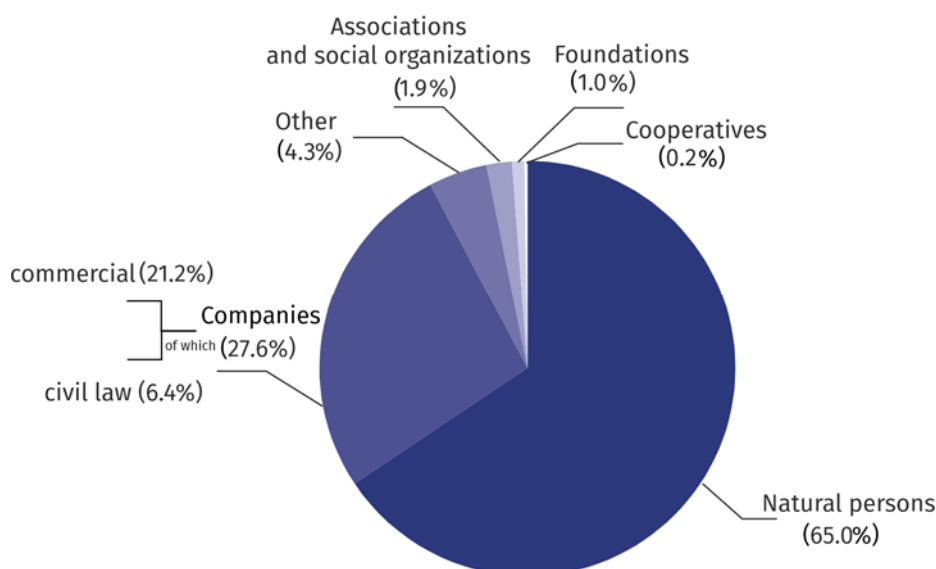
As in 2020, the vast majority, that is 874764, i.e. 94.3% of the total number of entities were private sector entities. Among entities of this sector, 68.9% represented natural persons conducting economic activity, primarily: in trade; repair of motor vehicles (121826 entities), professional, scientific and technical activities (101524 entities) and in construction (69793 entities).

There were 12283 public sector entities registered in the REGON register, which belonged mainly to the education section (4726 entities) and real estate activities (2649 entities).

The REGON register also includes entities for which the information on the form of ownership does not exist.

Public sector entities accounted for only 1.3% of total units in the Voivodship

At the end of December 2021, there were 602711 natural persons conducting economic activity registered in the REGON register, i.e. by 4.1% more than in the previous year. In the territorial cross-section, the highest increase took place in the following powiats: zwolleński (by 6.1%), piaseczyński (by 5.9%), ostrołęcki and warszawski zachodni (by 5.8% each), grodziski (by 5.7%). The decline in the number of natural persons was not recorded in any powiat or city with powiat status.

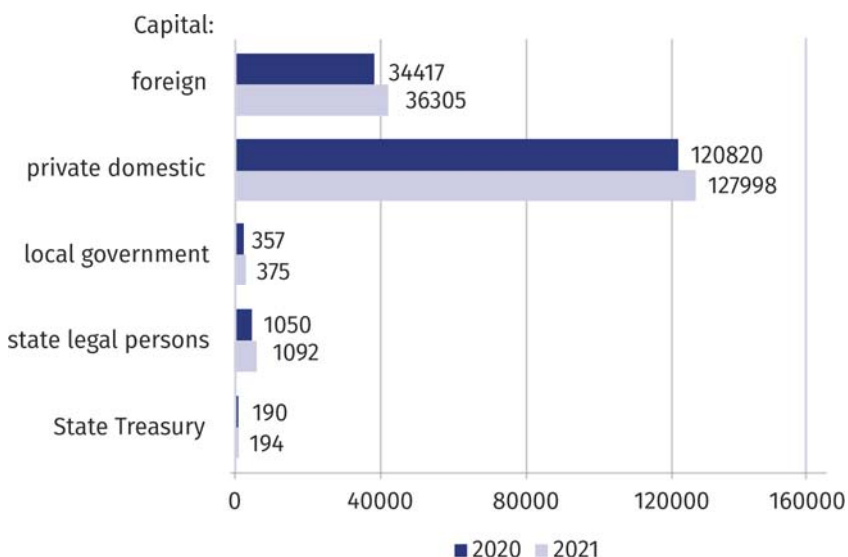
The highest share of natural persons in the total number of entities was in the powiats: zwolleński (84.4%), while the lowest in m.st. Warszawa (54.8%) and piaseczyński powiat (67.2%).

The number of registered commercial companies (196493) accounted for 33.1% of total commercial companies registered in the country. Over the year their number in the voivodship increased by 8.0%, and the largest increase was recorded in the powiats: węgrowski (by 30.0%), ostrołęcki (by 16.5%), szydłowiecki (by 15.0%). The decrease in the number of commercial companies was not recorded in any powiat or city with powiat status.

The vast majority of commercial companies were capital commercial companies (89.7%) and they were mainly limited liability companies (87.6%). Out of partnerships (10.3%) the most popular legal status were limited partnerships (5.7% of total commercial companies) and unlimited partnerships (3.6%).

Among commercial companies by type of capital, the highest increase compared to 2020 (by 5.9%) was recorded in companies with domestic private capital.

Activity of commercial companies concentrated primarily in the sections: trade; repair of motor vehicles (23.5%), professional, scientific and technical activities (16.5%), construction (10.5%), industry and information and communication (9.2% each).

At the end of December 2021, the number of registered commercial companies amounted to 59182, i.e. by 0.5% more than a year before. The highest increase was recorded in the powiats: kozienicki (by 3.6%), białobrzescki (by 3.4%), przysuski (by 3.3%), miński (by 2.6%) and gostyniński (by 2.5%). Whereas the highest drop was recorded in pułtuski powiat (by 4.0%). Commercial companies concentrated their activities primarily in the sections: trade; repair of motor vehicles (40.4%), industry (11.9%) and professional, scientific and technical activities (10.4%).

As of 31 December 2020, there were 17564 associations and social organisations registered, which means an increase by 3.1% as compared to the previous year. The highest increase was recorded in the powiats: gostyniński (a 5.8% increase), warszawski-zachodni (5.6%), wołomiński, wyszkowski and lipski (by 4.9% each). Whereas the decrease in the number of associations and social organisations applied only to Siedlce (by 1.9% less), białobrzescki and łosicki powiat (fewer by 1.6% and 0.9%, respectively).

The increase was also recorded in the number of registered foundations (5.2% in annual terms) and at the end of December 2021 it amounted to 9397. The highest increase was recorded in m.st. Warszawa by 338 foundations, in the powiats: piaseczyński – by 22, wołomiński – by 19. The highest decline in the number of foundations was recorded in nowodworski powiat – fewer by 3.

There were 1784 cooperatives registered in Mazowieckie Voivodship, i.e. less by 0.8% compared to the previous year. The highest decrease concerned the powiats: siedlecki (by 11.5%), płoński (by 10.3%), miński (by 8.3%), gostyniński (by 6.7%). The increase was recorded in the powiats: węgrowski (by 5.9%), radomski (by 5.6%) and m.st. Warszawa (by 0.6%). The above legal status was usually chosen by units conducting activity in the field of real estate activities – they accounted for 50.1% of total cooperatives.

At the end of December 2021, 11 state-owned enterprises were registered in the REGON register – which was by 1 fewer compared to the previous year. Out of these enterprises, the largest number of units dealt with industry (45.5%).

## Entities of the national economy by the number of employed persons

In Mazowieckie Voivodship, entities belonging to the group of micro enterprises (which at the moment of entering the REGON register provided for employment of up to 9 persons) prevailed, and accounted for 96.8% of total registered units.

The share of small entities (with expected number of 10 to 49 employed persons) amounted to 2.6%, and medium-sized enterprises (expected number of 50 to 249 employed persons) and large (expected number of 250 and more employed persons) amounted to 0.5% and 0.1%, respectively.

Micro enterprises most often conducted activity in the following sections: trade; repair of motor vehicles, professional, scientific and technical activity and construction.

In the group of small entities, except for trade; repair of motor vehicles dominated also units dealing with industry and education.

Among medium entities, the following sections prevailed: education, industry and trade; repair of motor vehicles.

In the case of large entities, the highest share concerned the following sections: industry, trade; repair of motor vehicles and public administration and defence; compulsory social security.

## Entities of the national economy newly registered and removed from the register

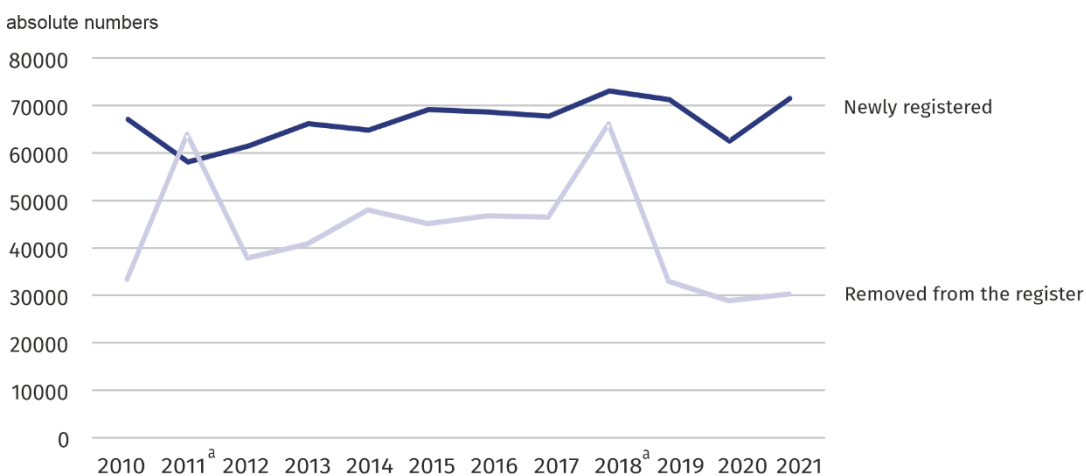
In 2021, there were 70751 new entities of the national economy registered in the REGON register, i.e. by 14.4% more than in the previous year. Natural persons conducting economic activity accounted for 70.0% of total new entities, while the share of companies amounted to 26.6%. Most new units were created in Warszawa (38600) and in the following powiats: wołomiński (2902), piaseczyński (2900) and pruszkowski (2075). Whereas the fewest new units were created in the following powiats: łosicki (157), lipski and żuromiński (217 each).

During the year, 30428 entities were removed from the REGON register (by 4.7% more than throughout 2020) and they were mainly natural persons conducting economic activity (84.1%). Most units were removed from the register in m.st Warszawa (14122), wołomiński (1358), piaseczyński powiat (1277), Radom (1203). Whereas the fewest removals were recorded in the following powiats: lipski and zwoleński (by 79 each) and łosicki (80).

96.8% of total entities accounted for micro enterprises (employing up to 9 persons)

In Mazowieckie Voivodship in 2021, there were 43 liquidated entities per every 100 newly registered entities

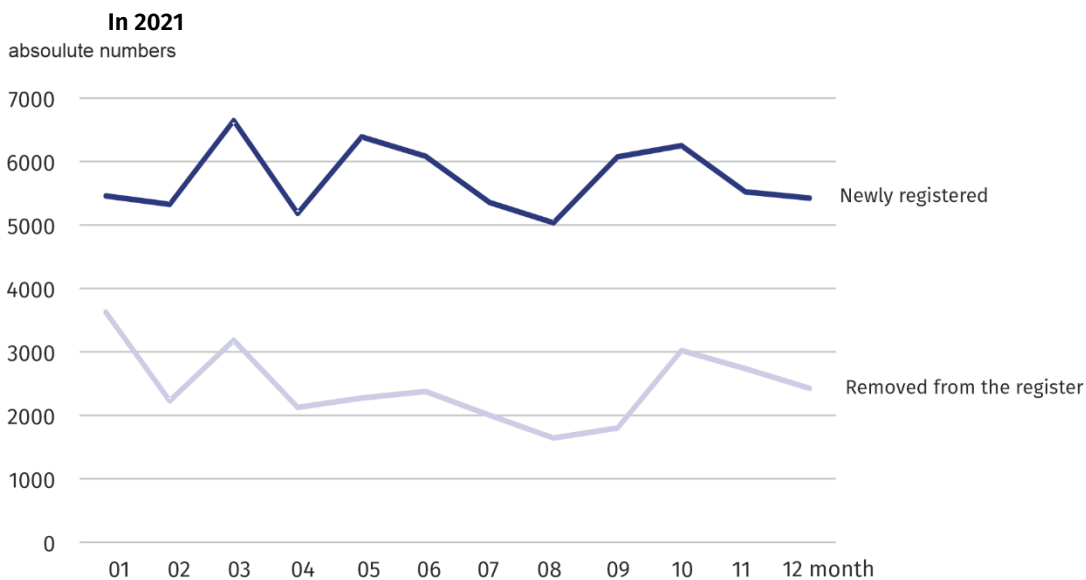
**Chart 5. Entities of the national economy newly registered and removed from the register**



<sup>a</sup> The increase in the number of entities deregistered in 2011 and 2018 was affected by the update of the REGON register based on information about deceased persons obtained from the PESEL register and an update based on information from the National Court Register on entities deleted from the National Court Register.

In 2021, the indicator measured by the ratio of the number of units removed from the register to the number of newly registered units in the Voivodship amounted to 43.0%. The highest value of this indicator was recorded in gostyniński powiat (69.6%), Ostrołęka (67.0%), and Płock (66.1%), przysuski powiat (63.4%), Siedlce and Radom (by 62.% each). The lowest value was recorded in zwoleński powiat (32.1%), lipski (36.4%), in m.st. Warszawa (36.6%), in warszawski zachodni (42.6%), in biatobrzeski powiat (42.8%). In monthly terms (as at the end of the month), the largest number of new registrations was in March (6834) and in May (6575), while the lowest number of new entities were registered in August (5182) and April (5334). The largest number of removals from the REGON register in 2021 occurred at the beginning of the year, i.e. in January (3737), and in March (3283) and at the end of the year, i.e. in October (3117), while the lowest number was observed in August (1705) and September (1862).

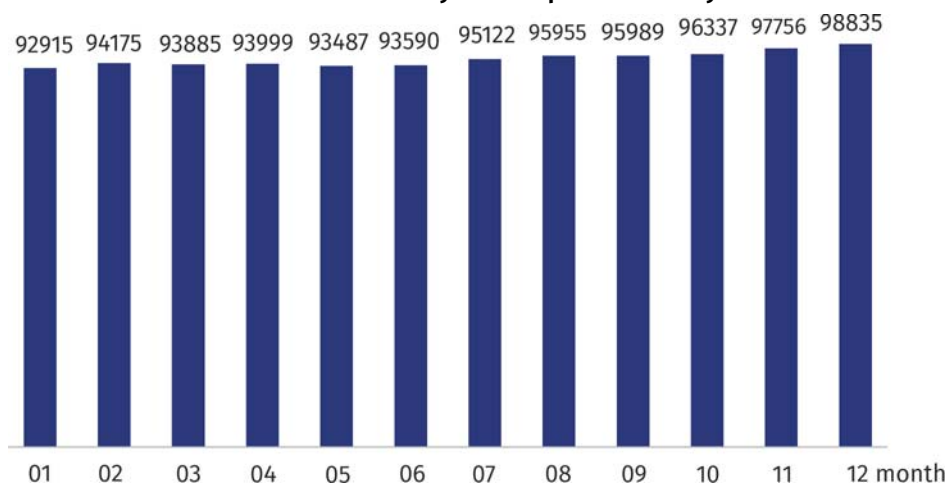
**Chart 6. Entities of the national economy newly registered and removed from the REGON register**



**Entities of th national economy with suspended activity**

The number of entities with suspended activity per year was higher by 8569 units, i.e. by 9.5%, and at the end of December 2021 and amounted to 98835. The vast majority of these entities (90.4%) were natural persons conducting economic activity. In monthly terms, the largest number of suspended activity in the REGON register occurred in the last months of the year: in December (98835), November (97756) and October (96337), and the lowest in January (92915).

**Chart 7. Entities of the national economy with suspended activity in 2021**

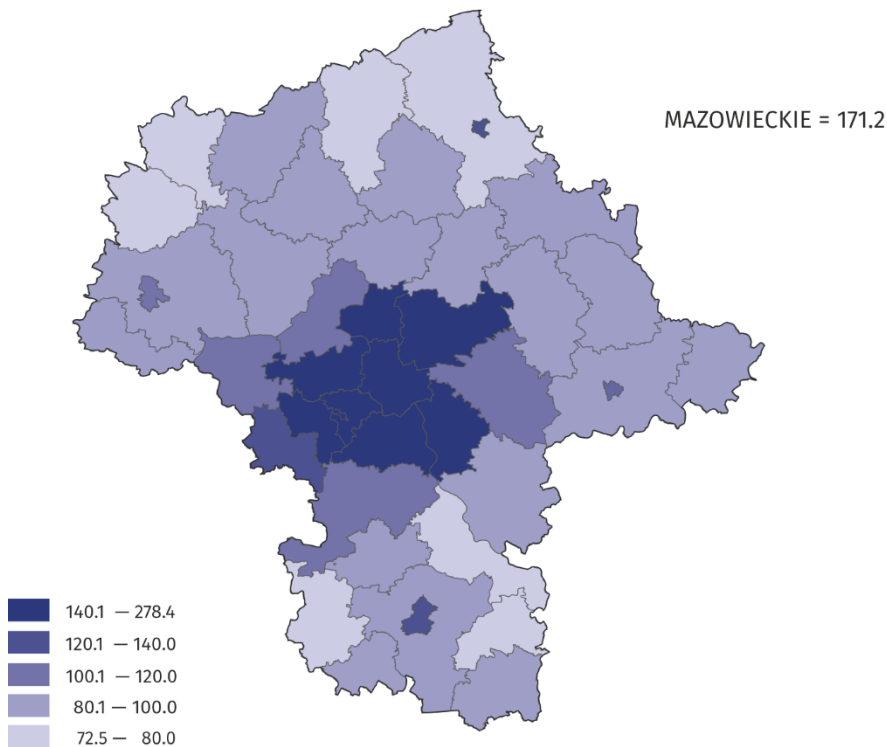


Per 1000 inhabitants, the number of registered entities was more than twice as high in warszawski stołeczny than in mazowiecki regionalny region

## Entities of the national economy per 1000 population<sup>1</sup>

In 2021, in Mazowieckie Voivodship there were 171.2 entities of the national economy registered in the REGON register per 1000 population. The highest values of this rate concerned m.st. Warszawa (278.4) and the following powiats: piaseczyński (207.1), pruszkowski (193.9), warszawski zachodni (189.0). While the lowest rates of intensity were recorded in the following powiats: zwoleński (72.5), żuromiński and przysuski (76.6 each), kozienicki (76.7).
